City of Lincoln High-Efficiency Clothes Washer Rebate Program Terms and Conditions:

To qualify for a rebate:

- Rebates apply only to high-efficiency clothes washers purchased on or after **July 1, 2015**.
- Used or reconditioned washers do not qualify for rebates.
- Applicant must be a water customer of the City of Lincoln utility system at the time of the purchase with an account in their name at the service address where the clothes washer is installed.
- The clothes washer must be a Tier 3 as determined by the Consortium for Energy Efficiency (CEE) on the date of the purchase. For the clothes washer qualifying product list, visit <http://www.cee1.org/resid/seha/rwsh/rwsh-prod.pdf>
- Applicant is not eligible for the rebate if he/she purchases a clothes washer for a new home or new construction or development, including apartments.
- Applicant is not eligible for clothes washer rebate if he/she received a previous clothes washer rebate from the City.
- To qualify for the rebate, the City requires an original or copy of a receipt
- The completed application form must be received no later than 90 days after the purchase date.

Please note:

- Rebates will be issued as a \$100.00 check from the City of Lincoln.
- Allow up to 90 days for your completed application to be processed and receive a credit.
- Rebates are subject to program funding availability.
- City does not warrant, endorse, or assume liability for the quality, performance or safety of any product or services performed by any retail outlet, contractor, or employees or agents of same, related to a purchase under this program.
- Installations may be subject to inspection and verification. Customer agrees to allow the City of Lincoln to inspect the fixture at the installation address by appointment with prior notification.
- Applications will be processed until funds are depleted.
- City reserves the right, at its sole and absolute discretion and at any time, to change any or all of the Terms and Conditions for the rebate program or to cancel the rebate program without prior notice.
- Incomplete applications will not be processed. Do not mail application with utility payment.
- Rebates not to exceed the purchase price.
- Incomplete or Illegible applications will be denied.
- You will be required to repay the rebate if any of these Terms and Conditions is found to have been false or is breached.
